- \* Service Connection Husband/Wife, Widower/Widow, Father/Mother, Grandfather/Grandmother, Sons/Daughters, Brothers/Sisters.
- \* Qualifying applicants may be admitted to social membership in the Home Association after a review and majority vote by the Board of Directors of the Association and entitled to the privileges, restrictions and limitations as may be provided by its By-Laws, but they shall not be permitted to vote, hold an office or take any active part in the deliberations of the Association.
- \* The Canteen and Social Rooms of this organization are under the control and management of the Board of Directors, Canteen Manager, On-Duty Bartender and Post Commander who have the power to suspend any member for any violation of the Canteen Rules and Regulations.
- \* Any person acting in an objectionable manner will be expelled from the premises. Authority to take such action is vested in the Canteen Manager, On-Duty Bartender, members of the Board of Directors or Post Commander. All incidents shall be reported to the Board of Directors and may be subject to suspension or revocation of membership from this organization.
